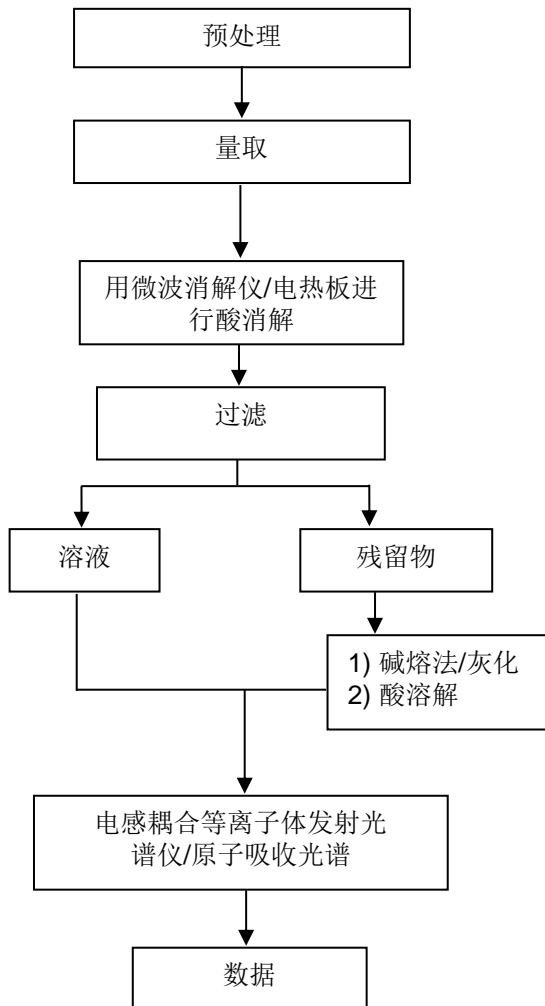

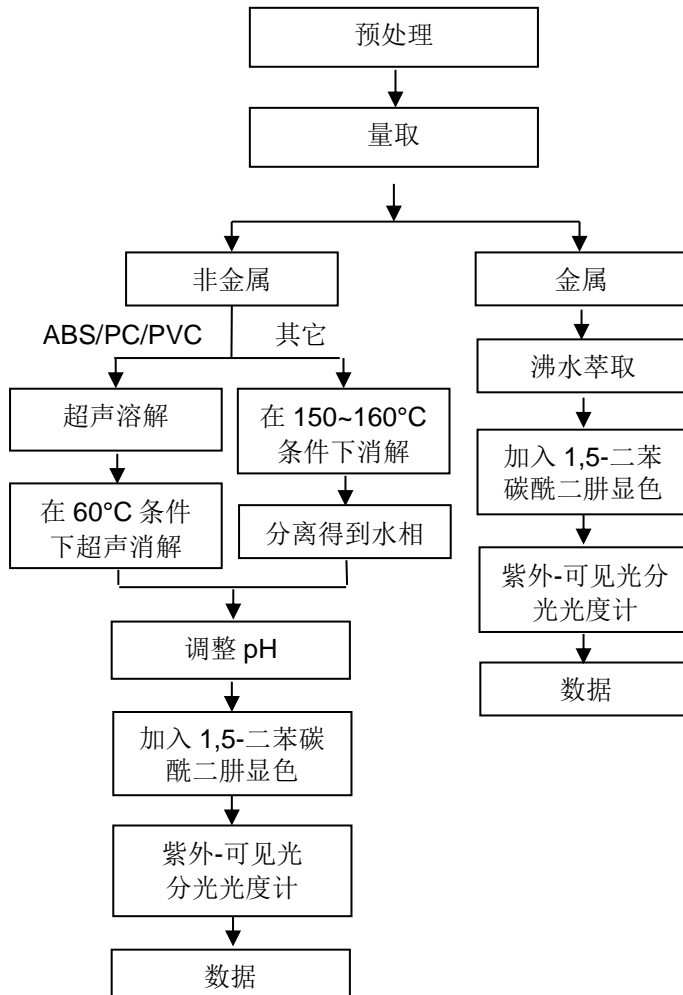

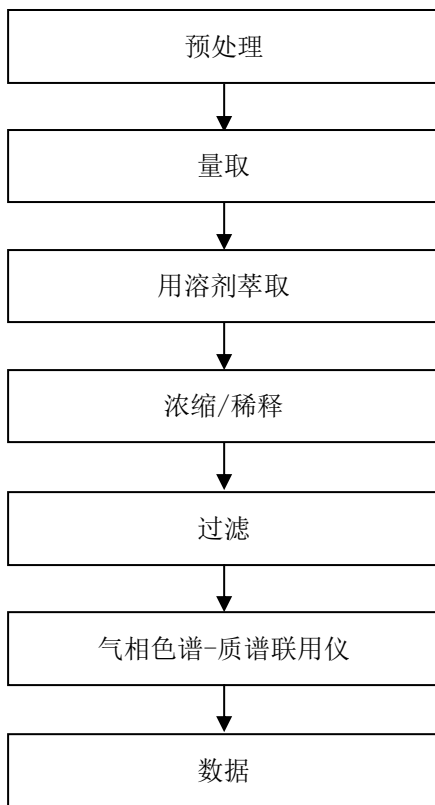

### PBB/PBDE/Phthalates 检测流程图



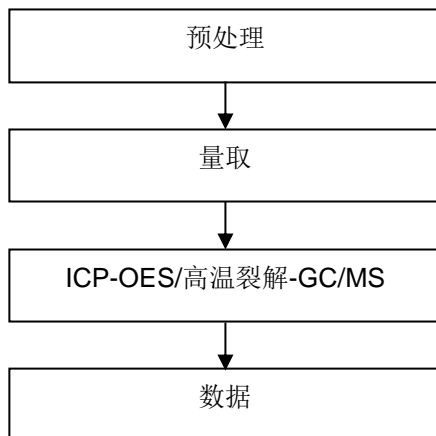

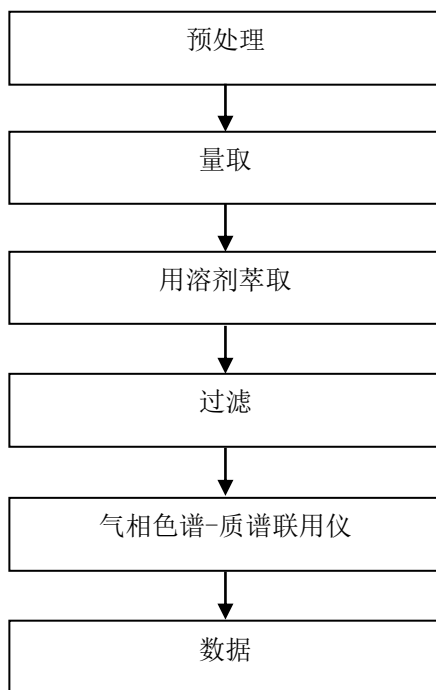
