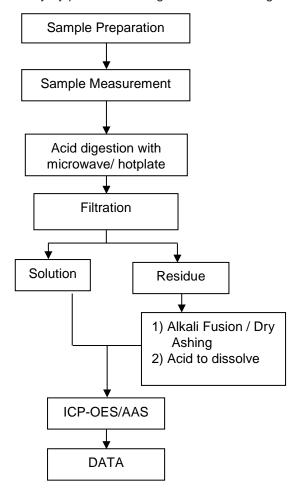





PBB/PBDE Testing Flow Chart







Phthalates Testing Flow Chart







Elements Testing Flow Chart







Halogen Testing Flow Chart








