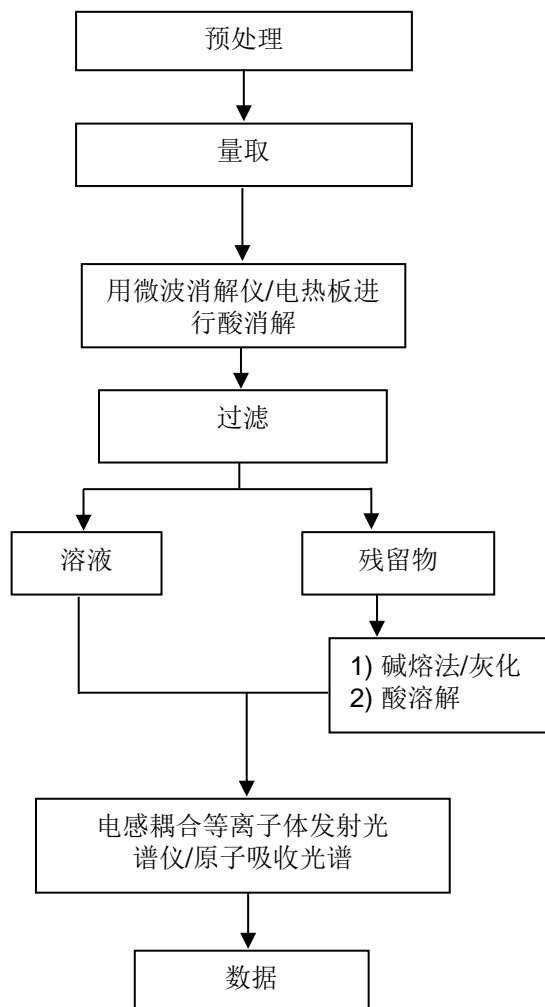

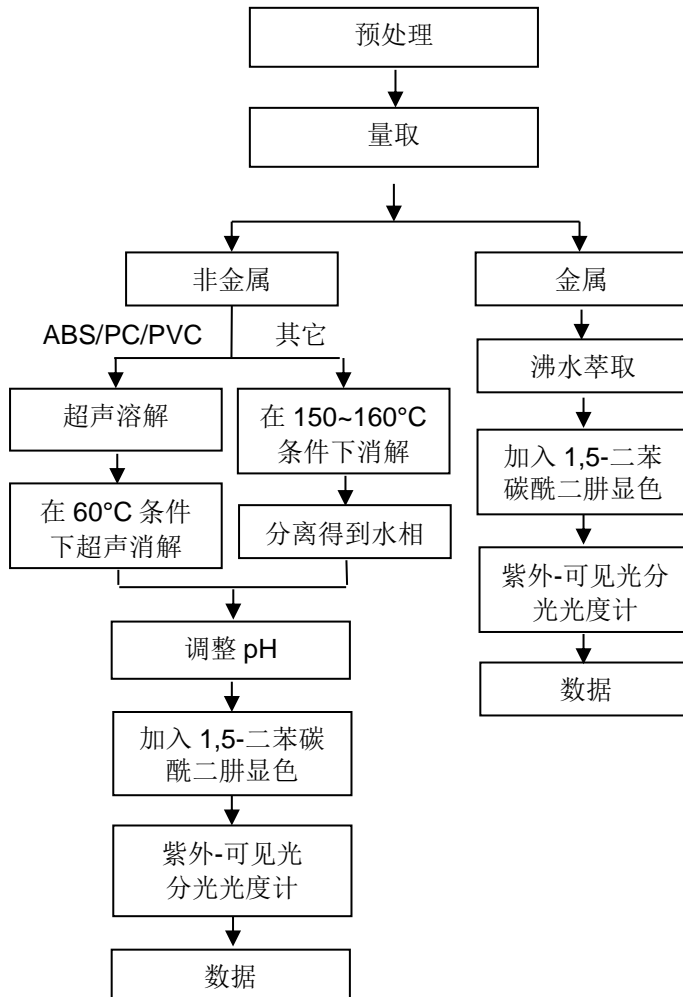

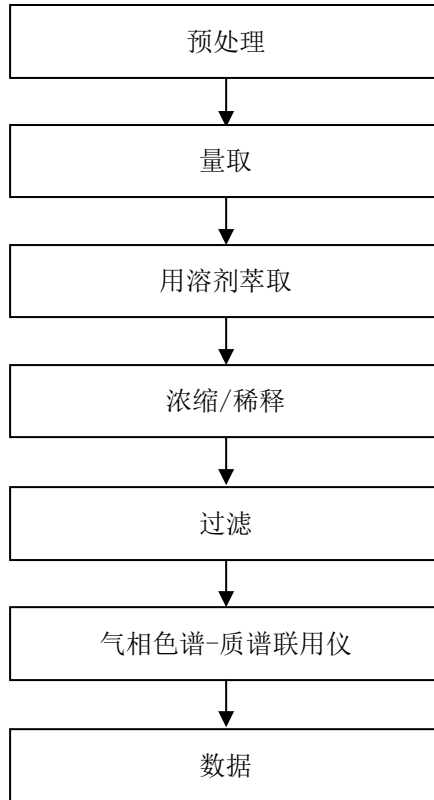
### 六价铬检测流程图

### PBB/PBDE/Phthalates 检测流程图

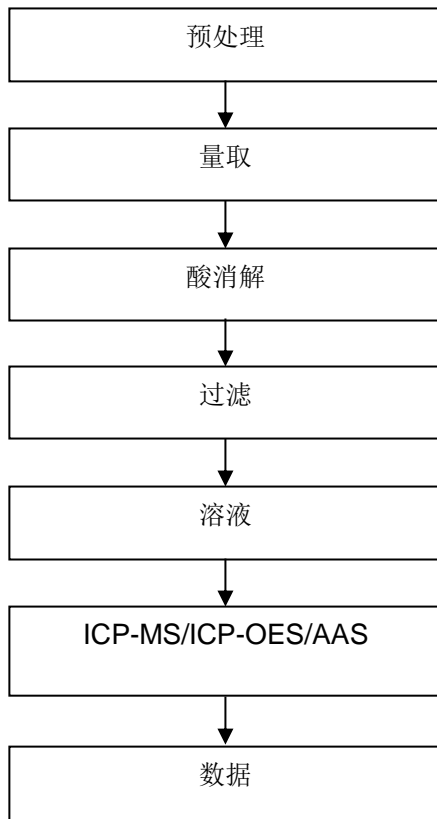

## 元素检测流程图



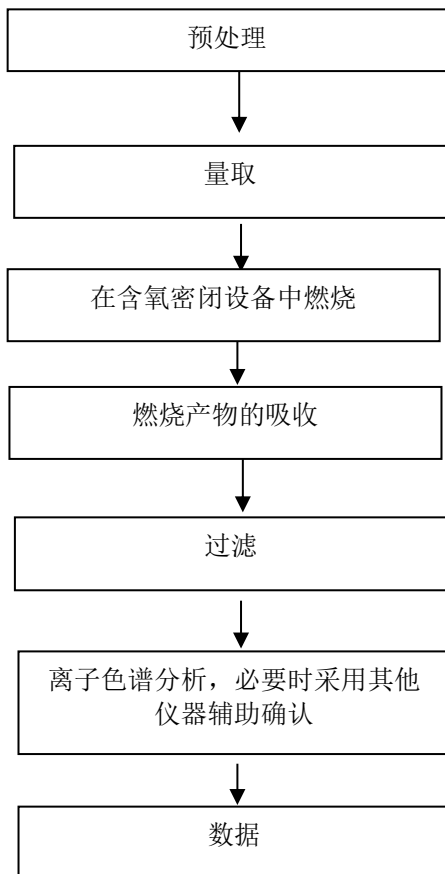

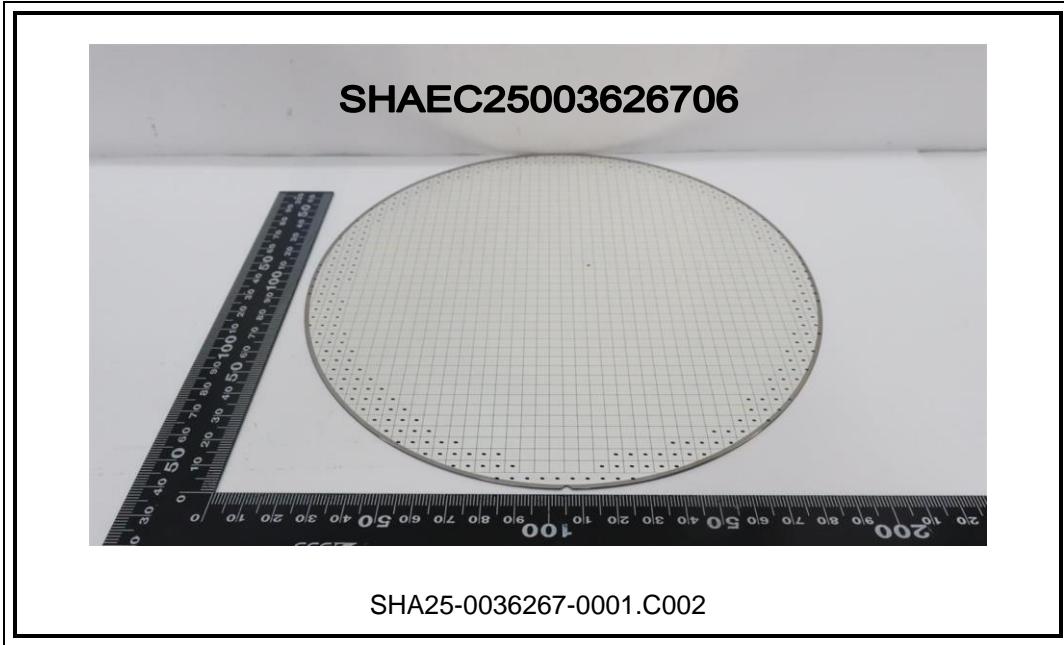
